This is regarding Compliance Reports submitted by MCKV Institute of Engineering, 243, G.T Road (North), Liluah, Howrah-711204, West Bengal for the Electrical Engineering program which was accredited by NBA in Tier-II for the academic years 2018-19 to 2020-21 and whose validity of accreditation has expired on 30.06.2021.

2. The National Board of Accreditation (NBA) has decided that in all cases of UG Engineering programs which were accredited in Tier I/Tier II for the Academic Years 2018-19 to 2020-21 i.e. up to 30-06-2021 and for which the concerned Institutions have submitted Compliance Reports, but the visit of Expert Team for data verification of the programs is pending because of the current pandemic situation due to Corona virus, the programs will be considered for accreditation of one year i.e. up to 30-06-2022 after data verification of the programs internally on the basis of the submitted Compliance Reports. The data submitted by MCKV Institute of Engineering, 243, G.T Road (North), Liluah, Howrah-711204, West Bengal in the Compliance Reports has been examined and verified in NBA. Based on the same, the Competent Authority in NBA has approved the following accreditation status to the programs as given in the Table below:
