- c. Our institute has applied for opening B.Voc in Automobile Servicing with intake capacity of 30 under the Department of Automobile Engineering from the A.Y. 2021-22.
 - d. Our institute has applied for opening B.Voc in Automotive Technology with intake capacity of 30 under the Department of Automobile Engineering from the A.Y. 2021-22.
 - e. Prof. Sarkar has informed that for all the courses, our institute has applied for the approval from AICTE and affiliation from MAKAUT.
2. Mr. Mojammel Rahaman raised an issue to set a deadline for collecting the data for the AQAR for the A.Y. 2020-21.
